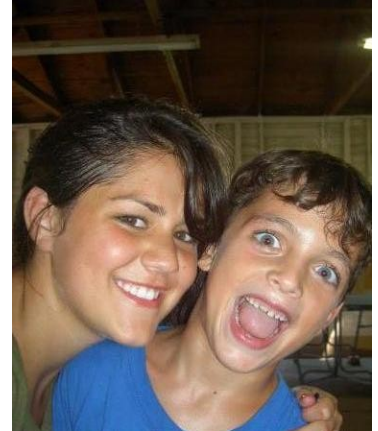

# Essential Information

## Our location

Camp is held at 2037 Hempel Ave. Gotha, FL 34734. Located on acres of beautiful grounds, facilities include a pool, lake, playground, grassy outdoor playing fields, and an air conditioned auditorium.

## Dates and Times

Camp will be running for 4 weeks. Camp begins on Monday, June 27th and runs through July 22nd. Monday through Friday, camp runs from 9:30 am—3:30 pm. Extended care is available, from 8am to 5 pm.

Please drop off and pick up promptly, so your child gets to participate in the full day of activities.

## Divisions

Camp is divided into 4 divisions:

### Younger division

Kids entering Pre-k, Kindergarten and First Grade.

### Older division

Kids entering 2nd grade to fifth grade

### VIPs

Pre-teens entering 6th and 7th grade.

### Teen Program

Girls entering eighth and ninth Grade.

### Pioneer program

Boys entering seventh, eighth and ninth grade.



### Arrival & Pick Up for three, four and five year olds

The youngest two bunks should be dropped off and picked up at their trailer, located off the road right after the pool.

### Arrival and pick up for all others

Camp begins every day, promptly at 9:30 AM. Be sure to drop-off your child between 9:15 AM and 9:30 AM, as on some days we will be leaving camp grounds right away. Drop-off and pick-up will be on the front porch of the main building. Please sign your child in and out. End of day pick-up begins at 3:15 PM and ends at 3:30 PM. Please be prompt in picking up your child.

### Change of Dismissal Plans

If your child's end of the day arrangement is different from normal, a parent must provide a written note for the counselor, or you can notify whoever is at the sign in and sign out sheet. Do not leave a phone message. This includes changes in car-pool arrangements, play dates, etc. Please avoid calling camp during the day with changes, unless it is a true emergency. If both parents are out of town, camp must be informed.

### What Your Child Needs In Camp

**Clothing:** Clothes should be comfortable, washable and appropriate for camp activities. Younger children should have a complete change of clothing to be kept at camp.

**Mark Clothing :** Clothing, especially outerwear, should be marked with your child's name.

**Additional Items:** campers will need to bring a bathing suit and towel, for swimming. Please send along sunscreen and a water bottle with your child, every day.

### Dress Code

For safety, children must wear appropriate shoes. Croc style shoes, although comfy and trendy, are not appropriate for athletic activities. It is mandatory that campers wear a CGI t-shirt and cap every Tuesday, for trip day. Additional camp shirts are available for purchase at \$6 each



### Lunch

A nutritious daily lunch will be provided to campers. Snacks and drinks will also be served throughout the day.

*A typical week's lunch menu may consist of the following:*

- Monday :** Lasagna and carrot sticks
  - Tuesday :** sandwiches and a vegetable
  - Wednesday :** pizza and cucumber logs
  - Thursday :** Fish sticks, rice and corn
  - Friday :** Tuna and Cream Cheese, or pb&j sandwiches, with a veggie.
- Peanut butter and jelly are available every day at camp.

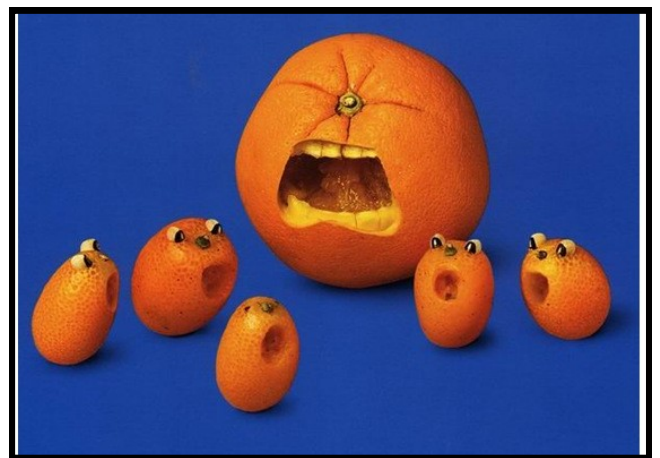

**June 28th:** All Campers need their camp t-shirt, bathing shoes and suit, and an extra t-shirt. They will be wearing their camp t-shirt in the water (to make the campers easier to spot), and will change into a dry shirt to return home.

A great indoor amusement park complete with bumper cars, arcades and laser tag. Please wear your t-shirt and cap, and bring a water bottle.

### **July 12th:**

Please wear your t-shirt and cap, and bring a water bottle.

**July 19th:** All Campers will need to wear their camp t-shirts and caps, please bring a water bottle. Y.D, O.D and VIP's will need a pair of thick socks.

### Treatment Procedures

Health screening of all records are done prior to the 1<sup>st</sup> day of camp. Records are screened to learn of any medication taken, allergies and illnesses. A chart with any important findings is distributed to staff during training. All our medical routines have been reviewed and approved by a local Pediatrician.

Our staff is trained in CPR and first Aid.

Health charts, emergency information and first aid kit are kept accessible to staff at all times, on and off site.

The closest hospital, mental care facility, fire station and police department were notified of the dates, location and participants in our program.

In case of emergency, we contact 911 and then the parents.

In non-emergency situations, parents are to be contacted immediately if campers are ill or injured and will require further medical care. We encourage parents to pick up the campers and bring them to their own doctors.

For medical injuries not requiring further medical treatment, camp provides First Aid.

Parents are to be contacted by the Health Care Manager to inform parents of steps taken.

The head counselor or Chani will be responsible for all health care and for administering medications. All medication to be administered during camp hours, must be clearly marked with camper's name. A separate note containing dosage instruction and parent signature must be sent as well.

## Transportation

Campers ride on professional tour busses.

Bus drivers and bus companies are all licensed, insured, bonded and informed of our safety and accident procedures and transportation requirements.

Busses are fully air-conditioned and counselors are trained to deal with all issues that may arise off site.

## Swimming, boating and water sports

All water activities are supervised by red cross lifeguards, and additional staff members in and out of the water. We have a beautiful swimming pool on-site. The campers swim in shifts of no more than 29 kids at once.

The campers go boating once a week, with a counselor on each boat, and a lifeguard on the lake as well.

## Staff

Our counselors are specially trained in childcare and Jewish education. Our counselors are known for their love and warmth for each child in their care. They work at Camp Gan Israel, because they are dedicated to giving the children a great experience. We conduct background checks on all our staff members, and take pride and full responsibility for each one.





### Judaica

Our Camp is a branch of the largest, and fastest growing network of Jewish Camps Worldwide.

Children experience and ultimately develop a love and pride of our vibrant culture. Friday Shabbat parties, Challah baking, weekly Judaic themes and Kosher food hunts, will all bring to life the values and beauty of our tradition.

### Overnight

Campers of the older division, who are entering 3rd grade, can participate in an overnight on **July 12th, at Turkey Lake Park**. As in the past years, we join two other camps for a very inspiring experience. Campers partake in a grand game of Capture the flag, a bar-b-q, a bonfire, great storytelling, etc.. Please see attached form.

### Performance

**July 21st**, in the evening, the campers will be putting on a great live performance, with music and special effects. We encourage campers who may not be at camp that last week, to still join us, in this grand finale. It's a great opportunity to bid the counselors farewell, and show grandparents and friends all that the kids have achieved in the weeks they were in camp.

### Personal Property

The Camp does not take responsibility for any personal items brought to camp. Personal sports equipment such as baseball bats, hockey sticks, sports balls etc., will be stored by the counselor and used under staff supervision.

ABSOLUTELY NO illegal substances or weapons of any kind will be allowed on camp grounds. Camp reserves the right to conduct searches when we feel necessary.

### Camper Pick-up and Drop-off

**New this year:** campers in the two youngest bunks, need to be dropped off and picked up at their trailers. A staff member will be outside the rooms to assist you.

Parents or guardians driving onto camp grounds should drive slowly keeping to a 5 mile mph speed limit. Please drive and park in designated marked areas only, since vehicles are not permitted anywhere else on camp property. Campers should be dropped off at the greeting area, where a staff member will be signing them in.

When arriving late, please walk your child into the building and  
o v e r   t o   a   s t a f f   m e m b e r .

Please drive in one direction, so as not to confuse any pedestrians. When leaving please follow the circular drive-through path and loop around to the exit onto Hempel Avenue. Please be extra careful to stay on the dirt road and be vigilant as you go around the bend which is near to the pool area, in case there are children coming back from swimming.

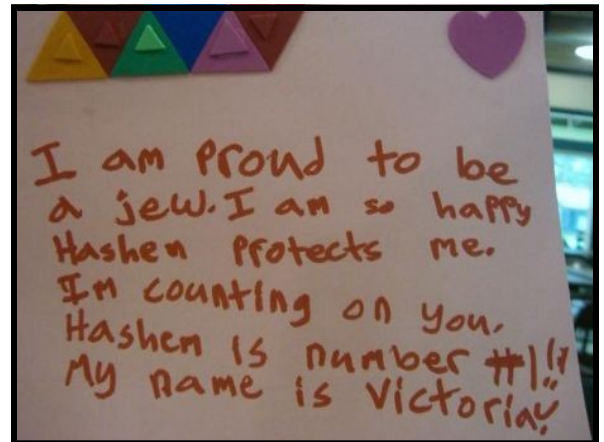
**It is integral for parents to sign their child in and out each day. We can only assume responsibility for children when we know that they were handed over to us. If a child was not signed in, we assume that he or she is still in his/her parent's care.**

### Extended Care

Extended care hours are 8:00 am to 5:00 pm. Sign in and sign out policies apply to extended care campers as well.

### No Smoking on CGI grounds

Please be advised that our policy is that there is no smoking on camp grounds.





**The following is a sheet of safety procedures, given to our staff. Our counselors are properly trained to follow them:**

\*In an emergency, call 911!

\*Prior to trips, all Camp attendees must be briefed on safety regulations. Bracelets will be provided. They must be worn. Counselors must keep campers real close and always in site, when off grounds.

\*in case of emergency, always contact Chani, or Rabbi Konikov

\*Never give any comments to media, lawyers or outside sources, unless specifically asked to do so by Camp Direction.

\*In case of a fire: evacuate building and step away (gather kids and keep away) from trees. If on fire: stop, drop and roll. It is a counselor's responsibility to care for campers during an emergency. Always stay with campers, continue to count campers and o your best, according to your training, to keep them safe.

\*In case of a thunderstorm and /or hurricane proceed to the Kramer dining Hall and follow safety procedures and instructions from Camp directors and Head Counselor.

\*If a child is missing, counselor should immediately contact head staff. Never leave other children unattended in order to search for missing camper. Once verified, head staff will send a staff member to the pool, lake and road to search for child. A search throughout camp grounds will then be organized, and authorities will be called.

\*If a stranger is seen in buildings or on property used by CGI, a staff member should approach the stranger and request that he ids himself and discloses the purpose of his visit. Contact Chani or Mike to verify. If unable to reach either, ask stranger to step away from the area until his story is verified.

\*Gather campers to a safe place.

\*Throughout the day, staff members should periodically take attendance and count their kids.

\*Buddy calls are required before, during and after swimming.

\*When leaving the pool area (and during the rest of the day) campers should be wearing sneakers or sandals. Kids running around barefoot will most likely end up getting hurt.

\*When hiking in the woods, counselors should look out for snakes and insects that may hurt campers.

\*In emergency situations, Camp directors and head counselor will contact parents. All numbers are on health forms.

PARTICIPANT AGREEMENT, RELEASE AND ASSUMPTION OF RISK**

In consideration of the services of Rebounderz Planet Jump, Inc., their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "RPJ"), I hereby agree to release, indemnify, and discharge RPJ, on behalf of myself, my spouse, my children, my parents, my heirs, assigns, personal representative and estate as follows:

(1) I acknowledge that my participation in trampoline court activities and other amusement activities entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. **The risks include, among other things:** Slipping and falling; collision with fixed objects or people; injuries including, sprains, fractures, scrapes, bruises and cuts, dislocations, pinched fingers and serious injuries to the head, back, or neck the negligence of other participants or myself; my own physical condition; physical contact with others. Furthermore, RPJ employees have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They might misjudge the weather or other environmental conditions. They may give incomplete warnings or instructions, and the equipment being used might malfunction. (2) I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks. (3) I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless RPJ from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of RPJ's equipment or facilities, including any such claims which allege negligent acts or omissions of RPJ. (4) Should RPJ or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs. (5) I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have. (6) In the event that I file a lawsuit against RPJ, I agree to do so solely in the state of Florida, and I further agree that the substantive law of that state shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining document shall remain in full force and effect.

**By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against RPJ on the basis of any claim from which I have released them herein. I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.**
